Guidelines and Eligibility Requirements

To be considered for a Last Dollar Scholarship, applicants must meet the following criteria:

1. By **June 1, 2009**, have filed this application. Applicants wishing funding for ANY part of the 2009-2010 school year must meet this June 1, 2009 deadline
2. **Two types of applicants:**
 - a. A high school senior who resides in or attends a high school in Allen County
 - b. A first-time college student within 2 years after high school graduation (who lived in or graduated from a high school in Allen County)
3. Must have demonstrated unmet need (Recipients must be Federal Pell grant eligible)
4. Must file the Free Application for Federal Student Aid (FAFSA) by that institution's **FAFSA priority deadline** (**NOTE:** Students are responsible for checking with their institution for the priority filing deadline date) or June 1, 2009, whichever comes first
5. Must be accepted to an accredited postsecondary institution and be enrolled as a full-time student in the Fall of 2009
6. By June 1, 2009, must have forwarded to the Lima/Allen County College Access Program office the documents necessary to complete this application (See next section.)

***DOCUMENTS THAT MUST BE SUBMITTED BY STUDENT
TO THE LIMA/ALLEN COUNTY COLLEGE ACCESS PROGRAM**

1. **A signed Last Dollar Scholarship Application Form**
2. **After submitting your FAFSA, you will receive a Student Aid Report (SAR), which is a summary of all the FAFSA information you submitted. Send a copy of your Student Aid Report (SAR). If you filed electronically or provided an email address on your paper FAFSA application, you will need to print your SAR from FAFSA on the web. If you filed the paper FAFSA and did not provide an email address, you will receive a paper SAR, which you should copy and submit. The completed copy of the SAR is needed to process the Last Dollar Application to determine whether a student demonstrates financial need.**
3. **A copy of the Financial Aid Award Letter for the postsecondary institution the student will attend**
4. **A copy of the student's high school transcript showing their cumulative grade point average and credits earned**

***Documents may be submitted separately, but it is the sole responsibility of the student to submit all the documents to the College Access Program by June 1, 2009**
